- The State Government has decided to form a separate Commissionerate for Vsm 2491 as Food Safety and Drug Control Administration as stipulated in the new Act. Food and Drug Control labs will also be upgraded and modernized. This Government is proposing to set apart Rs.50 crores for this purpose".
- 2. In Tamil Nadu, Prevention of Food Adulteration Act, 1954 was being ent reimplemented in both rural and urban areas by the Department of Public Health and Preventive Medicine. The Prevention of Food Adulteration Act 1954 has been repealed with Food Safety and Standards Act, 2006 (Central Act No. 34 of 2006) by Government of India. Food Safety and Standards Rules, 2011 have also been framed and the said Act and Rules have come into force with effect from 5th b. Food Safety Division headed by a Director, Food 1102 tauguAuld be
 - 3. The Government of India has enacted Food Safety and Standards (FSS) Act, 2006 which emphasizes the need for a structure exclusively for the Food Safety.

A series of incidents occurred in the past in Tamil Nadu by which consumers were put to grave health risks through sale of adulterated and expired food products as well as expired drugs. A series of raids were organized by the Civil Supplies and Consumer Protection Department in collaboration with Health Department to seize expired food products sold in the markets in various districts across the State. Substantial quantities of expired meat, processed food, soft drinks, etc., were seized and destroyed. A major expired-drugs racket was busted by the Drug Control Department in collaboration with the Police Department. In order to protect consumers who are at a grave risk to health, a Committee was constituted in G.O. (Ms). No.203, Health and Family Welfare Department, dated 21.07.2010 under the Chairmanship of Thiru.K. Rajaraman, formerly Commissioner, Civil Supplies and Consumer Protection Department with Director of Public Health and Preventive Medicine, Joint Director of Public Health and Preventive Medicine incharge of Prevention of Food Adulteration Act, Director of Drugs Control, Commissioner for Municipal Administration or his nominee, Director of Town Panchayat or his nominee, Director of Rural Development and Panchayat Raj or his nominee and a nominee of the Principal Secretary, Finance Department, Chennai as Members as decided in the meeting held on 3.6.2010 chaired by former Chief Secretary.

- 4. The Committee after studying the system in force in Maharashtra and Gujarat gave its report on 23.12.2010 and the Committee, among other things has made the following recommendations:-
- i. Merger of the existing Food Safety Wing of the Directorate of Public Health and Preventive Medicine and the Department of Drugs Control and formation of a new Tamil Nadu State Food Safety and Drug Administration (TNFS&DA)
 - ii. Since the two systems are related and function under two different Acts, they can function under one umbrella organization: "Tamil Nadu Food Safety and Drug Administration Department".
- iii. A senior super time scale IAS officer may be posted as State Commissioner of Food Safety for the newly proposed Tamil Nadu Food Safety and Drug Administration Department and he may be notified as the State Food Safety Commissioner under the Food Safety and Standards (FSS) Act, 2006. The Drug Controller is a technical post under the Drug & Cosmetics Act, 1940 and the Drug Controlling Authority under the Drug & Cosmetics Rules, 1945 may continue to be designated as Director and he will function under the administrative control of the Commissioner, Tamil Nadu Food Safety and Drug Administration Department.
 - iv. Tamil Nadu Food Safety and Drug Administration Department under the Commissioner would be having the following two wings:
 - a. Drug Control Division headed by a Director (Drug Control)
 - Food Safety Division headed by a Director, Food Safety who would be a Food Safety and Nutrition specialist.



- 5. The Government of India has informed this Government that the Prevention of Food Adulteration Act will be repealed by 4th August 2011 and the new Food Safety and Standards Act 2006 (Central Act) and Rules 2011 will come into force with effect from 05.08.2011. Accordingly, in the order fourth read above, orders have been issued notifying the Principal Secretary to Government, Health and Family Welfare Department as Commissioner of Food Safety for the State as stipulated in Section 30 of the Food Safety and Standards Act and Rule 2.1.1 of Rule 2011. The Designated Officers at the district level and Food Safety Officers for Urban and Rural areas have also been notified to implement the above Act and Rules in Tamil Nadu.
- 6. The Director of Public Health and Preventive Medicine in his letters second read above has submitted proposals for establishment of Food Safety Commissionerate at the Headquarters, Designated Offices in the Districts, appointment of Adjudicating Officers and Food Safety Officers for both rural and urban areas, strengthening of existing Food Analysis Laboratories with additional man power and establishment of Food Safety Appellate Tribunal indicating posts to be sanctioned together with the recurring and non-recurring expenditure. Similarly the Director of Drug Control in his letters third read above has submitted proposals for creation of posts to strengthen the Drug Control Wing and the Drug Testing Laboratories with sanction of new posts indicating the recurring and non-recurring expenditure. The estimated expenditures proposed by them are as below:

- 7. The Government after careful examination has decided to accept the proposals of the Director of Public Health and Preventive Medicine and Director of Drug Control and accordingly issue the following orders:-
- (i) A new Department called "Tamil Nadu Food Safety and Drug Administration (TNFS & DA) Department" integrating the existing Food Wing of the Directorate of Public Health and Preventive Medicine and the Drug Control Department is formed in Tamil Nadu and these two distinct vertical departments would function under one umbrella organization i.e. Tamil Nadu Food Safety and Drug Administration Department.

 The new Department will function under the administrative control of Health.

The new Department will function under the administrative control of Health and Family Welfare Department. The existing Head of the Department Code 19-06 used for Director of Drug Control will be renamed as 19-06. Tamil

Nadu Food Safety and Drug Administration (TNFS&DA).

- (ii) A post of Commissioner of Food Safety in the cadre of Commissioner and Secretary to Government is created for appointment as Commissioner of Food Safety to head the above newly formed Department. Public (Spl.A) Department will issue necessary orders in this regard.
- (iii) Following posts are sanctioned to establish the Food Safety Wing in the newly formed Commissionerate of Food Safety and Drug Administration.
- (a) The existing post of Joint Director of Public Health and Preventive Medicine in the Directorate of Public Health and Preventive Medicine is upgraded as Additional Director of Public Health and Preventive Medicine in the scale of pay Rs.37400-67000+GP 8900 and redeployed to the new Department of Tamil Nadu Food Safety and Drug Administration for appointment as Director and Additional Commissioner of Food Safety.

(b) One post of Deputy Director of Public Health and Preventive Medicine Grade-I in the scale of pay of Rs.37400-67000+GP 8700.

(c) One post of Deputy Director (Administration) in the scale of pay of Rs.15600-39100+GP 6600.

(d) One post of Deputy Director (Food Safety Information Management) in the scale of pay of Rs.15600-39100+GP 6600 and Two posts of Data Entry Operator to be filled up by outsourcing.

(e) One post of Health Officer in the scale of pay of Rs.15600-39100+GP 5700.

- (f) One post of Assistant Public Prosecutor Grade-II in the scale of pay of Rs.15600-39100+GP 5400
- (g) One post of Administrative Officer in the scale of pay of Rs.15600-39000+ GP5400.
- (h) One post of Statistical Assistant in the scale of pay of Rs.9300-34800+GP 4400.
- (i) Two posts of Assistant in the scale of pay of Rs. 5200-20200+GP 2800.
- (j) Three posts of Junior Assistant in the scale of pay of Rs. 5200-20200+GP.2400.
- (k) Two posts of Steno-Typist in the scale of pay of Rs.5200-20200+ GP 2800.
- (I) Two posts of Office Assistant in the scale of pay of Rs.4800-10000+GP 1300
 - (m) Three posts of Driver in the scale of pay of Rs.5200-20200+GP 2400.
- (n) The existing posts of three Food Safety Officers (formerly Food Inspector), one Superintendent, one Statistical Assistant, one Assistant Public Prosecutor Grade-I, Assistant Public Prosecutor Grade-II, Three Assistants, Two Steno Typists, Two Junior Assistants, one Typist and one Office Assistant already sanctioned to the Food Wing of the Directorate of Public Health be transferred to the new Department of Tamil Nadu Food Safety and Drug Administration. The Director of Public Health and Preventive Medicine should take necessary action to release the individuals with instructions to join in the new department.



- (iv) Sanction is accorded for the creation of 32 posts of Designated Officer in the scale of pay of Rs.15600-39100+GP 5700 for the establishment of office of the Designated Officer in all the Revenue Districts. The office shall be established in the office of the Deputy Director of Health Services located in the District Head Quarters. The office of the Designated Officer, Chennai shall be located in the Office of the Director of Public Health and Preventive Medicine. Sanction is also accorded for the creation of 32 posts of Assistants in the scale of pay of Rs.5200-20200+GP 2800, 32 posts of Junior Assistant in the scale of pay of Rs.5200-20200+GP 2800, 32 posts of Data Entry Operator on outsourcing basis, 32 posts of Office Assistant in the scale of pay of Rs.4800-10000+GP 1300, and 32 posts of Driver in the scale of pay of Rs.5200-20200+GP 2400 for establishing the office of the Designated Officers in the Districts to implement the Act.
 - (v) Sanction is accorded for the creation of 385 posts of Food Safety Officer for rural areas and 199 posts of Food Safety Officer for urban areas in the scale of pay of Rs.9300-34800+GP 4400 for establishing the Office of the Food Safety Officer. They will implement the Food Safety and Standard Act 2006 and the Rules 2011 in the area notified to them. These posts should be filled up by redeployment of same number of Health Inspector posts from the Directorate of Public Health and Preventive Medicine. The office of the Food Safety Officer be established in the respective Block Primary Health Centre in the rural area and in the respective Corporations / Municipalities in respect of urban area.
- Appellate Tribunal be formed in the Commissionerate of Food Safety and Drug Administration, Chennai. Sanction is accorded for the creation of one post of Presiding officer in the rank of District Judge and one post of Registrar in the scale of pay of Rs.37400-67000+GP 8800 to the above Food Safety Appellate Tribunal. The supporting staff of one post of Assistant Public Prosecutor Grade-I in the scale of pay of Rs.15600-39100+GP 5700, one post of Superintendent in the scale of pay of Rs.9300-34800+GP 4800, one post of Assistant in the scale of pay of Rs.5200-20200+GP 2800, one post of Data Entry Operator on outsourcing basis, one post of Record Clerk in the scale of pay of Rs.4800-10000+GP 1400, one post of Driver in the scale of pay of Rs.5200-20200+GP 2400 and one post of Duffadar and one post of Office Assistant in the scale of pay of Rs.4800-10000+GP 1300 are sanctioned to the Food Safety Appellate Tribunal.
- (vii) The existing Drug Control Department under the Director of Drug Control be brought under the administrative control of Commissioner of Food Safety and Drug Administration and he will continue to function with designation as Director (Drugs Control). Sanction is accorded for the creation of additional posts of one Assistant Director for the formation of new zone IV in Chennai suburb, five Senior Drug Inspectors in the scale of pay of

Rs.15600-39100+GP 5400 and 42 Drug Inspectors in the scale of pay of Rs.15600-39100+GP 4900, One post of System Analyst and three posts of Data Entry Operator by outsourcing for strengthening of the Drug Control Wing as proposed by the Director of Drug Control. The new posts shall be distributed to the Head Office and Regional level Offices as indicated in the Annexure-I to this Government Order.

- (viii) Sanction is accorded for the creation of additional posts of seven Senior Analysts in the scale of pay of Rs.15600-39100+GP 5400, seven Junior Analysts in the scale of pay of Rs.9300-34800+GP 4600, five Micro Biologists in the scale of pay of Rs.15600-39100+GP 5400, five Assistants in the scale of pay of Rs.5200-20200+GP 2800, Six Store Keepers in the scale of pay of Rs.5200-20200+GP 2800, Six Data Entry Operators on outsourcing basis, Ten lab. Technicians Grade-I in the scale of pay of Rs.5200-20200+GP 2800, six Lab. Technicians Grade-II in the scale of pay of Rs.5200-20200+GP 2400, one Electrician in the scale of pay of Rs.5200-20200+GP 2000, four Watchmen in the scale of pay of Rs.4800-10000+GP 1300, five Sweepers and six Lab. Attendant in the scale of pay of Rs.4800-10000+GP 1300 to establish the Food Analysis Laboratories as proposed by the Director of Public Health and Preventive Medicine.
- (ix) Sanction is accorded for three posts of Senior Analysts in the scale of pay of Rs.15600-39100+GP 5400, two posts of Lab. Technician in the scale of pay of Rs.5200-20200+GP 2800 and three posts of Lab. Attendant in the scale of pay of Rs. 4800-10000+GP 1300 for strengthening of the existing Drug Testing Laboratory.
- (x) The District Revenue Officers of the Districts who are the Additional District Magistrates be designated as the Adjudicating Officers under section 68 of the Food Safety and Standard Act for the implementation of the Food Safety and Standard Rules 2011.
- 8. The Government sanction a sum of Rs.64.24 crores (Rupees Sixty four crores and twenty four lakhs only) towards recurring expenditure and Rs.3.82 crores (Rupees three crores and eighty two lakshs only) towards non-recurring expenditure to the Food Safety Wing of the newly formed Tamil Nadu Food Safety and Drug Administration Department towards staff salary, vehicles to the State level and District level officers, stationary, telephones, other contingencies, furniture, equipment, etc. as detailed in the Annexure-II to this order and a sum of Rs.3.04 crores (Rupees three crores and four lakhs only) towards recurring expenditure and Rs.14.95 crores (Rupees fourteen crores and ninety five lakhs only) towards non-recurring expenditure to the Drug Wing of Tamil Nadu Food Safety and Drug Administration Department towards staff salary, stationary, telephones, other contingencies, furniture, equipment, computer, machinery, etc. as detailed in the Annexure-III to this order. The Government also sanction a sum of Rs. 30 lakhs (Rupees Thirty lakhs only) for payment of cost of food samples to be taken for analysis.

- 11. The Commissioner of Food Safety is the estimating, reconciling and controlling authority for the above new expenditure and receipt sub-heads opened at para 9 and 10 above. The Pay and Accounts Officers / Treasury Officers concerned are requested to open the above new heads of account in their books.
- 12. The new posts sanctioned in para 7 above is for a period of one year and further continuance shall be obtained from time to time. They shall be filled up by following the service rules in force. The post of System Analyst and Data Entry Operator shall be filled up on outsourcing basis. Transparency in Tender Act should be followed wherever applicable. The posts of Duffader and Sweeper should be filled up duly after identifying and surrendering equivalent posts matching the monetary value of new creation from the respective directorate. Wherever procurement of machineries and equipments is to be made, the required fund shall be transferred to the PD account of Tamil Nadu Medical Services Corporation for making such procurement.
- 13. The Government direct that necessary Government norms should be followed while procuring the newly sanctioned motor vehicles. Proposals be sent to Government for fixing the fuel ceiling after vehicles are purchased. The post of Office Assistant should not be filled up merely based on the sanction of posts and the Zee bag norms of 12:1 should be followed and excess vacant posts be surrendered.
- 14. The Government authorize the Designated Officers to draw and disburse the salary in respect of Food Safety Officers.
- 15. The expenditure sanctioned in para 8 above shall constitute an item of 'New Service' and the approval of the Legislature will be obtained in due course. The expenditure should initially be met by an advance from the Contingency Fund and orders for sanction of Contingency Fund Advance will be issued by the Finance (BG I) Department. The Commissioner for Food Safety is directed to send an

application in the prescribed form along with a copy of this order to Finance (BG I) Department for sanction of the advance. He is also requested to send necessary draft explanatory note to include this expenditure in the Supplementary Estimates 2011-12 to Finance Department without fail.


